The carnival operation and all carnival personnel must comply with the conditions set forth below:

1. Applicant and his/her employees will not violate any of the laws of the State of Illinois or of the United States or any ordinance of the City of Warrenville in the conduct of this carnival.
2. There shall not be set up or operated any gambling device, lottery, number or paddle wheel, number board, punch board, or other game of chance, or any lewd, lascivious or indecent show or attraction making an indecent exposure of the person or suggesting lewdness or immorality.
3. Applicant must provide affirmative documentation which demonstrates that none of the carnival personnel who will be attending or operating child-oriented rides or shows is a child sex offender as defined in 720 ILCS 5/11-9.3 or 11-9.4.
4. All personnel associated with the carnival shall, at all times, wear photo I.D.'s.
5. Any personnel who will attend or operate child-oriented rides or shows shall be separately listed on the permit and shall further be required to wear special forms of identification at all times. No other personnel shall attend or operate child-oriented rides or shows.

6. Before issuance of a carnival license, the City shall investigate and be satisfied that the carnival will operate in accordance of this Ordinance. The applicant will submit fees necessary to pay the expense of this investigation and to aid in policing the grounds and otherwise to compensate the City in such amount as the corporate authorities may determine. Such amount shall be paid by applicant prior to the issuance of the license. Any overpayment with respect to police services actually provided will be refunded.
7. Police Officers shall have free access to the grounds and all booths, shows and concessions on such grounds at all times.
8. If the carnival is to be conducted in whole or in part on City property or if Police services will be provided for the carnival, applicant shall submit a copy of certificate of liability insurance naming the City as an additional noncontributory primary insured, reasonable cleanup bond and a hold harmless agreement approved by the City. The certificate of liability insurance shall be in such form and amount not less than general liability coverage in the amount of \$1,000,000 combined single limit and \$2,000,000 aggregate.
9. A list of specific rides and amusement games and booths and a layout of where each will be located must be submitted before license is issued.
10. An application fee of \$250 must accompany this application
