

RESOLUTION NO. R2022-27

**A RESOLUTION APPROVING THE PURCHASE OF
ONE FORD EXPLORER UNMARKED POLICE VEHICLE FROM
CURRIE MOTORS COMMERCIAL CENTER AND VEHICLE EQUIPMENT FROM
ULTRA STROBE COMMUNICATIONS, INC.**

WHEREAS, the City is a home rule municipal corporation pursuant to Article VII, Section 6(a) of the Constitution of the State of Illinois of 1970; and

WHEREAS, the Northwest Municipal Conference ("**NWMC**"), is a corporate organization representing municipalities and townships located within the State of Illinois and the Counties of Cook, DuPage, Kane, Lake and McHenry; and

WHEREAS, the City participates in the NWMC Suburban Purchasing Cooperative ("**SPC**"), which permits local governments to purchase commodities and services according to contracts negotiated by the NWMC, resulting in significant savings for the City; and

WHEREAS, the City has identified the need to replace Vehicle #205 with one Ford Utility Police Interceptor Explorer with certain factory upgrades ("**Vehicle**") and certain additional equipment ("**Equipment**"); and

WHEREAS, the SPC sought bids for the award of SPC Contract # 204 ("**SPC Contract**") for the purchase of the Vehicle; and

WHEREAS, the SPC identified Currie Motors Commercial Center ("**Currie**") as the low responsible bidder for the SPC Contract for the Vehicle in the total not-to-exceed amount of \$33,083.00; and

WHEREAS, the City staff has determined that the SPC's purchasing policies satisfy the City's competitive bidding requirements; and

WHEREAS, Ultra Strobe Communications, Inc. ("**Ultra Strobe**") submitted a quote for the Equipment and its installation in the Vehicle in the amount of \$14,113.67; and

WHEREAS, the City has a positive relationship with Ultra Strobe, which has provided similar equipment and installation services to the City in the past; and

WHEREAS, the City has budgeted sufficient funds in the Fiscal Year 2023 Budget for the purchase of the Vehicle and the purchase and installation of the Equipment; and

WHEREAS, the Mayor and the City Council have determined that it is in the best interest of the City and the public to approve the purchase of the Vehicle from Currie and the purchase and installation of the Equipment from Ultra Strobe as set forth in this Resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF WARRENVILLE, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Recitals. The recitals listed above are incorporated in this Resolution as if fully set forth in this Ordinance.

SECTION 2: Approval of Purchases. The Mayor and the City Council hereby approve the purchase of the Vehicle from Currie in a total amount not to exceed \$33,083.00 and the purchase of the Equipment and its installation in the Vehicle from Ultra Strobe in an amount not to exceed \$14,113.67, for a total amount of \$47,196.67.

SECTION 3: Execution of Required Documentation. The City Administrator, or his designee, is authorized to execute, on behalf of the City, all documents acceptable to the City Administrator and the City Attorney necessary to complete the purchase of the Vehicle from Currie and the Equipment and its installation from Ultra Strobe.

SECTION 4: Effective Date. This Resolution shall be in full force and effect following its passage and approval in the manner provided by law.
