He also shared an article that discussed the idea of continuing to develop a seamless, regional trail system through central DuPage County. The article also highlight that on June 4th, Friends of the East Branch DuPage River Trail, a local bike advocacy group, will host guided biking and walking tours of potential corridor routes along the trail, south of 22nd Street. Commissioner Sikaras thought this event is of interest to BPAC members.
